**Publishes final draft technical standards on  
disclosure of indicators of global systemic  
importance by G-SIIs**

*18 February 2021*

The European Banking Authority ("EBA") published its final draft Implementing Technical Standards ("ITS") on the disclosure of indicators of global systemically important institutions ("G-SIIs"). These standards help to identify which banks are GSIIIs and specify the formats and instructions in accordance with which G-SIIs disclose the information required under the Capital Requirements Regulation ("CRR") and aim at ensuring consistency of information. ## China Baowu Steel's net-zero target is just the start

"China's largest steelmaker, Baowu Steel, has committed to carbon neutrality by 2050, ten years earlier than the Chinese government's national target. However, the pathway to decarbonization for China's steel industry will be long and in many ways more difficult than in other countries, due to the relatively young operating fleet that is heavily reliant on coal and constraints of steel scrap availability."
