Tax For All

We would like to bring to your attention that on the 17th of January 2023, the Department of Taxation (DoT) issued an announcement informing the taxpayers regarding the implementation of the new platform “Tax For All” (TFA) which will gradually replace the existing platform “TAXISnet”.

In accordance with the announcement, an important element for the smooth transition to the new platform is the email address of the taxpayer which is used by the DoT for communicating with the taxpayers. In this respect, in case that the email address which appears in TAXISnet for a taxpayer is incorrect should immediately proceed with amending its email address since its correctness is essential for the transfer of the taxpayer’s account to the new platform. The instructions for amending the email address can be found in the [announcement](#) issued by the DoT.

At a first stage the implementation will concern indirect tax where the users will be able to access the following:

- Submission of VAT and VIES returns.
- Submission of VAT refund forms.
- VAT statements.
- Perform payments.

- Communication with the DoT.
- Issuance of VAT registration certificates.
