Deadlines for settlement of taxes through self-assessment

We would like to inform you of the following deadlines for the settlement of taxes due in relation to rental income, dividends and passive interest income:

Special defence contribution (SDC) on gross rental income received by Cyprus tax resident companies and Cyprus domiciled tax resident individuals during the period 01/07/2025 – 31/12/2025, if such tax is not withheld by the tenant.	31 January 2026
General Healthcare System contributions on gross rental income received from sources within or outside Cyprus by Cyprus tax resident individuals (both domiciled and non-	31 January 2026

domiciled) during the period 01/07/2025 – 31/12/2025, if such contributions were not withheld by the tenant.	
General Healthcare System contributions on gross rental income received during the period 01/07/2025 – 31/12/2025 from properties located within the Republic by non-Cyprus tax resident individuals, if such contributions were not withheld by the tenant.	31 January 2026
Special defence contribution (SDC) on dividends and passive interest received (from foreign sources) by Cyprus domiciled tax resident individuals, and under certain conditions by Cyprus tax resident companies, during the period 01/07/2025 – 31/12/2025.	31 January 2026
General Healthcare System contributions on dividends and passive interest (from foreign sources) received by Cyprus tax resident individuals (both domiciled and non-domiciled) during the period 01/07/2025 – 31/12/2025.	31 January 2026

In case the above tax liabilities are not settled by the due dates, penalties and interest will be imposed on the amounts due.
