DAC 6

Additional Extension of the period for non-imposition of administrative fines for overdue submission of DAC6 information

We would like to inform you that on the 4th of June 2021, the Tax Department announced that no administrative fines will be imposed for the overdue submission of DAC6 information that are submitted by 30th of September 2021 (previously 30th of June 2021), for the following cases:

- 1. Reportable cross-border arrangements (RCBAs) that were implemented between 25 June 2018 and 30 June 2020, which had to be submitted until 28 February 2021;
- 2. RCBAs made between 1 July 2020 and 31 December 2020, which had to be submitted until 31 January 2021;

- RCBAs made between 1 January 2021 and 31 August 2021, which had to be submitted within 30 days from the day they were ready or available for implementation, or the first step in the implementation has been made (whichever occurred first);
- 4. RCBAs for which secondary intermediaries provided assistance, advice or aid between 1 January 2021 and 31 August 2021, and had to submit information within 30 days beginning on the day after the assistance, advice or aid was provided.
