Tax For All (TFA)- Updates



We would like to inform you that the first stage of implementation of the new Single Tax Administration Portal - Tax For All - (TFA), which will progressively replace (amongst others) the TAXISnet platform has been finalized and the new platform will go live on 27 March 2023.

The Tax Department has announced that as from 27 March 2023 all VAT returns (including special tax and farmers schemes), VIES returns and refund requests will be submitted only through the TFA platform.

The 16 March 2023 will be the last day that the TAXISnet platform will be accessible for submission of VAT returns, VIES returns, refund request and for verifying the email address of the taxable person.

An informative email regarding the transition to the TFA platform will be forwarded by the Tax Department to the email address indicated in TAXISnet platform of each taxable person.

As from 27 March 2023 all payments in relation to Value Added Tax (VAT) will only be performed through the TFA platform.

Payments can be executed through:

1. A valid credit/debit card
2. Commercial banks by the usage of Internet Banking or at the tills of the banks that offer this service.

As from 27 March 2023 the payment slips to be used for performing payments at bank tills will be available only through the TFA platform.

In addition, upon implementation of the new platform all existing forms as well as the payment codes for the settlement of VAT and VIES liabilities will be abolished.
